Christ Kid's is for children that are 6 weeks through 4 years of age (4K). Our program promotes learning opportunities through many activities including worship, music, art, and computer. Child development is a continually growing field producing knowledge of how children grow and learn. We know all preschoolers need to grow spiritually, emotionally, and socially. The level of development of each child is recognized on an individual basis. The curriculum is the foundation for teaching and gives direction to our program. It is based on carefully planned units of study or "themes". A variety of resources are used to create a balanced program of both teacher-directed and child-directed experiences.

Learning is fun! In this Christ-centered atmosphere, the teachers and the curriculum reinforce and encourage a child's ability to have fun while learning. Children are given the opportunity to use their imagination and creativity while in a challenging and loving environment promoting socialization, exploration, and discovery.

Requests for enrollment will be filled according to the following priority categories.

1. Children currently enrolled in Christ’s Kids and siblings.
2. All others.

Pre-Registration applications and registration fees for currently enrolled children must be received by **January 21, 2022**. All available spots will open to the public January 24, 2022. **No applications will be accepted unless accompanied by a registration fee.** A reminder letter and any additional paperwork needed to complete your file will be mailed in June/July. If we cannot offer your child placement in the program, your child’s name will be placed on a waiting list.

The child’s age will determine what class he/she is eligible to attend. When registering your child please apply for the appropriate class that corresponds to his/her age as of September 1, 2022. We place children in classes based on the following criteria: age, boy/girl ratio (if possible), teacher input, parent input, and personalities. **If you wish to make a request for class placement it must be submitted at the time of registration. All requests will be given consideration.**

Extended Session Policy and Procedures

We at Christ Kid's Preschool and Mother's Day Out want to provide this extension to our ministry with as much care and thought as we do our regular session. Our ultimate goal is to provide a safe, loving, Christian environment for our extended session children. Please take time to familiarize yourself with the procedures and fees so that you can help us better serve you. If you have any questions or concerns, please contact Jenny Srygley at 205-995-0165. Thank you for your cooperation.

Registered Children-Fees: \$5.00 per hour

Christ Kids Extended Session hours are from **7:30am until 9:00am** each morning and from **1:00pm until 4:00pm** each afternoon. **If you have registered your child for the extended session, you have committed to specific days and times and will be expected to pay for all registered days.** We must have an Extended Session Registration Form on file for all registered children. Any days/hours used outside of your registered time will be considered drop-in hours and you will be charged a fee of \$12.00 per hour. You will be billed for all registered days at the first of every month, and payment will be due by the 10th of each month to avoid a late fee of \$10.00.

Drop-In Children-Fees: \$12.00 per hour

Because of safety issues we will not be able to take every request for drop-in. Please see the director 24 hours in advance for availability. Teachers will not be able to approve drop-in hours.

Late Pick-up Fees:

Christ Kid's regular hours are from 9:00am until 1:00pm. Children must be picked up **no later than 1:10 p.m.** if they are not registered for Extended Session. If registered for Extended Session, children must be picked up **no later than 4:00.** ***A \$10.00 late fee will be charged if you pick your child up by 4:05. A \$1.00 fee will be charged for every minute after 4:05.** All late fees are due by the following day. **After the third late fee an additional \$10.00 will be charged to every late fee thereafter.** **Payment for late pick-up will be due the following day to avoid a late fee.**
